Mr. Millet announced some upcoming meetings and the upcoming 2019 NOLASEC Lower Mississippi River Communications Exercise, scheduled for 19 December 2019.

Mr. Millet recognized David Heximer (V.P. Acadiana SubChapter), Cdr. Eric Acosta, InfraGard Louisiana Board Chairman, and SA Robert (Bob) Thibault, FBI New Orleans / InfraGard Louisiana Coordinator.

Mr. Millet introduced the first speaker, Ed Flynn -V.P. Louisiana Chemical Association, who gave a presentation on the Louisiana Chemical Association's history and role in the area of Homeland Security.
