Mr. Millet called the meeting to order at 10:05 am.

Mr. Marco Bodellini led the group in the Pledge of Allegiance and a moment of silence.

Mr. Millet thanked Patricia Hood of Sirius Solutions and Andrea Bryant of Check Point for sponsoring lunch for today's meeting.

ASAC Jeff Veltri gave some opening remarks on behalf of SAC Bryan Vorndran. ASAC Veltri introduced himself and spoke about the importance of private sector partners to the FBI.

SA Bob Thibault introduced himself as the InfraGard Coordinator and spoke about threats in Louisiana and how the private sector supports the FBI's mission as subject matter experts. He reminded members to login to the InfraGard portal periodically to ensure that their credentials remain current.

Mr. Millet introduced COL Terry Ebbert (USMC ret.) of the City of New Orleans.

COL Ebbert gave an overview of public safety in New Orleans. He spoke about the difficulties of managing local emergencies and the role of local responders in planning and response.

Mr. Millet introduced Mr. Allen Phelps of Trust Farm, LLC, who gave a presentation entitled National Security Risk: Impact of Foreign Influence Activities on U.S. Critical Infrastructure Functions. Mr. Phelps spoke about nation state-sponsored insider risks. He discussed methods of investigating insider threats as well as how to mitigate the risks.

Mr. Millet introduced Col. Kenneth P. Donnelly (ret.) of the Louisiana Cybersecurity Commission and LTC Steve Durel of the Louisiana National Guard Cyberguard, who spoke about the mission of the commission and how resources to manage cybersecurity incidents in Louisiana are distributed. He provided an overview of ransomware threats that are currently the most prevalent threat in Louisiana. LTC Durel provided some additional details on ransomware threats. COL Donnelly discussed steps that organizations should take in order to plan, predict, protect, detect, respond and recovers to cyber incidents.

SA Corey Harris spoke further about ransomware threats and business email compromise incidents. He discussed some of the indicators of the threats and how to prevent them.
